

# ANN STOOKEY FUND FOR NEW MUSIC ANNOUNCES COMMISSIONING GRANT FOR MAJOR NEW CHORAL WORK BY COMPOSER GREGORY SPEARS

Los Angeles, California (February 2, 2017): The Ann Stookey Fund for New Music ("ASFNM") today announced that it has awarded a grant in the amount of \$25,000 to underwrite the commissioning of a new choral work by Gregory Spears (www.gregoryspears.com).

The new work will be a cantata for mixed choir and obbligato chamber ensemble, approximately 30 minutes in length, and will premiere during the 2018-19 performance seasons of the four choral organizations in the consortium.

Spears attended the Eastman School of Music, earned a master's degree at Yale, and took his Ph.D. at Princeton. Of his recent work, *The Wall Street Journal* said, "Mr. Spears writes brilliantly for vocal ensembles." The *Philadelphia Inquirer* said his "Requiem" bore "a modern sense of theatrical timing that keeps your ears on edge until the last note."

"We are delighted to work with a consortium of highly regarded, leading edge choral organizations to identify the next generation of great choral composers and to support efforts to bring their work to audiences," said Joe Waz, ASFNM chair. "With this latest commission to Gregory Spears, who has been hailed for his 'exquisite, distinctive (compositional) voice', the Fund is pleased to continue its unique role in expanding the choral arts in Ann's memory."

From Donald Nally, Conductor of The Crossing:

The opportunity to commission another substantial work through the support of the Ann Stookey Fund for New Music is extraordinary; we are so grateful for the generosity of Joe and his family in making this possible. I
